#### **ROY CRISS**

Mr. Criss has served three years as the Marketing Manager for the lowa DOT's Office of Aviation. He has produced an award-winning video that was distributed nationally.



He has also worked five years as the Air Service and Public Relations Manager for the Des Moines International Airport. Also, handles business development and marketing. Enplanements have increased by 100,000 while he has been in this position and the Airport has been featured in two international publications.

Previously, Mr. Criss was self-employed for 25 years as an Adult Skills Development Trainer serving Public and Private sector clients.

He has also been a Standup Comic for 25 years. 10 years touring full-time. He has appeared on Showtime Cable network 42 times and has opened concerts for Chicago and Air Supply.

Mr. Criss developed his management skills while working for Pfizer, Inc. for 12 years, holding three management positions. These being Production Supervisor, Training Coordinator and Personnel Associate.

#### CRAIG SMITH, A.A.E.

Craig Smith is the current Aviation Director for the Des Moines International Airport for the City of Des Moines, responsible for the day to day operation of the Airport. Craig has



held this position since October 1, 2005. 
